

## Leicester Windsurfing and Stand Up Paddle Boarding Club Ltd Temporary Member Booking Form

The "Temporary Member Booking Form" forms a contract between the Temporary Member and the Leicester Windsurfing and Stand Up Paddle Boarding Club Ltd. The Temporary Member is required to complete all sections of the form and to confirm that they understand the risks associated with Windsurfing and Stand Up Paddle Boarding at the King Lear's Lake.

Temporary Members must be over 18 years old. Temporary Members under 18 years old may only sail under the direct supervision of their Legal Guardian or Parent. The Legal Guardian or Parent therefore registers as the Temporary Member and assumes full accountability at all times for the supervision and the safety of the person/s under 18 years of age. The Legal Guardian or Parent must remain at the King Lear's Lake with any Temporary Member under 18 years old.

## Booking Terms:

**Risk Statement:** It must be recognised that windsurfing and/or stand up paddle boarding is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part at the Kings Lear Lake in Windsurfing and/or Stand Up Paddle Boarding, you agree and acknowledge that:

1. You are aware of the inherent element of risk involved in the sport of Windsurfing and Stand Up Paddle Boarding and you accept responsibility for exposing yourself and if appropriate minors under the age of 18 years for whom you are accountable to such inherent risk whilst taking part in Windsurfing and/or Stand Up Paddle Boarding.
2. You will comply at all times with the instructions of the LW&SUPC Ltd Officers and/or Members present. Specifically in respect of setting up and beaching windsurfing boards/sails and stand up paddle boards, wearing appropriate clothing and footwear, wearing buoyancy aids/life jackets, remaining within sight of the launching beach and being recovered by the safety boat whilst on the lake.
3. You are aware of the risks associated with Leptospirosis (Weils Disease) when swimming in or taking part in water based activities on open waterways and lakes. These risks arise through windsurfing and stand up paddle boarding with open wounds. Minor open wounds can be covered with water proof plasters. Visitors should avoid putting their hands near their mouth or nose whilst on or around the lake and must always wash hands before eating. A Leptospirosis Card is available for further information on your request.
4. You are aware of the risks associated with Blue Algae, particularly in the summer months, when swimming in or taking part in water based activities on open waterways and lakes. Blue Algae appears as blue green algal blooms or foam around the edges of the lake. Strong presence is usually but not always advised by the County Council Representatives. These risks arise through contact, swallowing or breathing in droplets of contaminated water. It is essential to wash hands before eating and to shower after Windsurfing and/or Stand Up Paddle Boarding.
5. You are aware that Windsurfing Masts when falling or flying in strong winds can cause serious injury to other park users and windsurfers. Temporary Members must seek assistance from a Club Official or Member before carrying or temporarily laying down a Windsurf Sail in the Launching Area.
6. You must respect other users of the lake ie Tri-Athlete Swimmers, Model Boats, Fishermen. Achieved by maintaining at least ten board lengths from other users.
7. You accept responsibility for any injury, damage or loss to the extent caused by your own negligence.
8. You will not participate in Windsurfing and/or Paddle Board Activities whilst your ability to take part in Windsurfing and/or Stand Up Paddle Boarding is impaired by alcohol, drugs or whilst unfit to participate.
9. The provision of assistance to Temporary Members (Minors under the age 18 years must still be supervised by their Legal Guardian when being instructed by Club Officials or Members) by Club Officials or Club Members is limited to such assistance, as can practically be provided in the circumstances.

## Tuition/Instruction:

You understand that Club Officials/Members are giving Temporary Members the chance to experience windsurfing and/or Stand Up Paddle Boarding. You will be offered the chance to take part in activities under the guidance of a club representative who has been assessed by the club to be competent and sufficiently experienced to supervise your experience. These representatives may not be qualified instructors. The Temporary Member experience is not intended to provide tuition or instruction.

The club very much hopes that you will enjoy the experience and will be able to advise you on how to obtain professional tuition and instruction should you wish to take your experience to the next stage.

## Cancellation:

You understand that the Temporary Member experience may be cancelled at any stage due to bad weather eg thunderstorms, high wind, equipment failure or other unforeseen events.

**Misconduct:**

You understand that the Club Official or Member may ask anyone who refuses to comply with these "Booking Terms" or who misconducts themselves in any way or who causes damage or annoyance to other persons to leave the lake and the vicinity of the launch area immediately.

**Data Protection/ GDPR:**

The information given by you on this original "Temporary Membership Form" will be stored in LW&SUPC Ltd "Records Folder". Your "Temporary Membership Form" will be retained for three years. The information on the "Temporary Membership Form" will only be used by LW&SUPC Ltd or it's Insurers in the event of a legal claim by you against LW&SUPC Ltd.
